ARTICLE II – PURPOSE OF AGREEMENT

WHEREASKMCLU and BBSPL agree that all discussions between KMCLU and BBSPL are non-binding unless and until the parties enter into written, definitive agreement signed by their duly authorized representative and neither party shall be obligated to enter into such an agreement.

WHEREAS KMCLU and BBSPL agree that all cost & expenses will be borne by BBSPL which is incurred under the ESD Program, and BBSPL will not demand any kind of money in any form from KMCLU and or its students.

WHEREASBBSPL anticipates that KMCLU will elect to engage BBSPL as the primary and preferred training provider and for job-oriented training program.

"Students" hereby refers to all the students of KMCLU.

ARTICLE III - SCOPE OF ACTIVITIES

3. ROLES AND RESPONSIBILITIES

The proposed roles and responsibilities of the parties in connection with this proposed relationship are described as under:

3.1 BBSPL Responsibilities via ESD Program

- To provide insight of the ESD Program to Students and Faculty
- To engage its personnel to deliver courses under ESD Program
- Provide Free of Cost Training to Graduate Students as per ESD Program
- Provide Training by Skilled Trainers and Experienced Industry Experts
- Provide the Participation/Training completion certificates for all students who have successfully completed the course
- Provide fair assessment of individual students to make them aware of their position in their respective career options
- Provide opportunity for Paid Internship to students after completing the training course as per ESD Program
- Provide Full Time Job Option to students with Industry Giants; after completing the Degree.
- Students' progress review meeting with KMCLU management at end of Basic
 & Advanced Training milestones
- Strengthening ICT capacity of the teachers through Faculty Training Programme.

3.2 KMCLU Responsibilities

 Provide permission to BBSPL to conduct the ESD Program for the KMCLU Students

 - Provide necessary permissions to students to go through paid internship under the ESD Program
- Appoint a SPOC for the ESD Program with whom ESD Program team may coordinate for various activities and conduct review meeting.
- The faculty members of KMCLU may be engaged in consultancy activities of BBSPL. The consultancy will be governed by the Consultancy Policy of KMCLU.

ARTICLE IV – DURATION OF MOU

4. DURATION

7.1

The MOU shall be effective from the date of signing, and shall be valid for a term of five (5) years, unless terminated earlier by either party, or extended mutually by both parties hereto, on the same terms and conditions as herein.

ARTICLE V - TERMS AND CONDITIONS

5. TERMS AND CONDITIONS

- KMCI U hereby agrees and undertakes to perform its obligations under this MoU including the activities as described.
- All the services being provided by BBSPL to KMCLU under the ESD Program will be free of any cost to KMCLU.
- All expenses which are incurred to run the ESD Program will be borne by BBSPL.
- The MOU shall only govern the provision of services provided under the ESD Program, a program governed by BBSPL to KMCLU.
- The MOU is non-binding on KMCLU and BBSPL and the ESD Program Team.
- Any software required, except the laptop/desktop for the students, to run the ESD Program will be provided by the ESD Program.
- All classes under the ESD Program will be conducted online and if there is any need to conduct offline classes, then KMCLU facility will be utilized for the same.

ABREACH OF MOU

In the event of any breach of the terms of this MOU, which is capable of rectification, by either party hereto, such other party shall be entitled to calcupon the party to rectify such breach within fifteen days from the date of the notice, failing which the breach shall be deemed to be a material breach and shall entitle such other party to rescind this MOU for material breach.

5.2 Termination

This MOU will terminate upon written notice by either party. The notice of termination should be issued at least 30 days before the intended date of termination unless extended or terminated earlier. If at any time any party wishes to withdraw from further evaluations and discussions in connection with the subject matter of this MOU and terminate the MOU, it may do so with or without cause and without liability by providing the other party with written notice of its intention to withdraw from further evaluations and discussions.

The following obligations will survive termination of this MOU for any reason. Use and nondisclosure of confidential information.

Indomnification and Liability

5.3. LIMITATION OF LIABILITY

Neither party shall be liable for any indirect, punitive, special, incidental or consequential damages arising out of or in connection with this MOU, whether for breach of this MOU or in torts, including loss of business, data, revenue, profits, or for any third-party claims against the other (except as specifically admitted by paragraph 2 below) whatsoever.

ARTICLE VI - ARBITRATION

It this informal resolution does not resolve the dispute, then the matter will be reterred to and settled by binding arbitration in accordance with the Arbitration and Conciliation Act. 1996. The Status of any such arbitration shall be Lucknow, U.P. The award of the arbitration may be enforceable in any court of competent nurrediction. Each party shall bear its own costs and fees in connection with the arbitration.

6.1. GENERAL

This MOU shall not be construed to be an agency or a partnership or joint venture of an employment relationship. Neither party shall be entitled to bind the other party with any third party by its actions, unless it has specifically obtained the prior wroten consent of such other party to do so.

Right of authority to assume or create any obligations or responsibility on behalf of or a the name of the other party, or bind the other party in any manner or thing whatsoever. Neither party nor its personnel shall be considered employees of the other.

Neither party shall assign or transfer this MOU or any benefits or rights or obligations accruing to it under this MOU, without the prior written consent of the other party

The MOU supersedes all prior oral or written communication, discussions and representations communicated between the parties hereto in respect of the subject matter of this MOU. Any modification to this MOU shall only be made by way of a westen document duly executed by representatives of both parties hereto.

Any notice under this MOU will be in writing and delivered by hand or by registered mail, return receipt requested, to the other party at the registered office or as may be substituted by the notice. If any notice is sent by mail, notice will be effective on the date of receipt.KMCLU shall maintain at all times, a one-point contact for the FSD Program being conducted. Any change in the contacts below will be notified to Program I ead of ESD Program.
