Memorandum of Understanding

ABOUT GGSIPU: Guru Gobind Singh Indraprastha University (GGSIPU) is first University established in 1998 by Govt. of NCT of Delhi under the provisions of Guru Gobind Singh Indraprastha University Act, 1998 read with its Amendment in 1999. The University is recognized by University Grants Commission (UGC), India under section 12B of UGC Act.

It is a teaching and affiliating University with the explicit objective of facilitating and promoting "studies, research and extension work in emerging areas of higher education with focus on professional education, for example engineering, technology, management studies, medicine, pharmacy, nursing, education, law, etc. and also to achieve excellence in these and connected fields and other matters connected therewith or incidental thereto.

ABOUT KMCLU:

Language establishes identity of a nation. Language is also the means of identification, creation, preservation and extension of knowledge. It helps individuals and communities to connect with the world. As a subject, Language attracts many scholars and thinkers to explore its various unexplored dimensions. Many efforts are being made by the government to connect language with the country's heritage and also promote quality research in the area. The National Education Policy (NEP 2020) also emphasizes on promoting multilingualism and using the power of language in teaching and learning. Supporting these initiatives, the University too is attempting to contribute extensively towards promotion of languages.

Established under the Uttar Pradesh Arabi Farsi Universities Act 2009 (U.P. Grants Commission. In the month of February, 2020, the State Cabinet, passed the proposal to rename the University as 'Khwaja Moinuddin Chishti Language University.' Situated on Sitapur-Hardoi Bypass Road, the University aims to equip its students with quality education along with a deep understanding of the cultural fabric of the country and inspires them to contribute progressively towards building a knowledge society. The University started its first academic session in August 2013 with students pursuing studies in Urdu, Arabic, Persian, English, Hindi, Geography, History, Economics, Home Science, Physical Education, Political Science, Education, Commerce, Computer Science, Business Administration and Journalism and Mass Communication under its Graduate and Postgraduate programmes. Apart from these, Diploma courses have also been a popular option among students enrolling in the University. At present this strength has gone upto 4253 and number of programmes offered by this university has also increased significantly. Since its inception the University has grown considerably in its scale and scope. It now offers a plethora of learning opportunities to the students from within and outside the state and with a rich blend of professionalism and tradition, this University has already established a niche in the academic circle of Uttar Pradesh. Professional courses such as Engineering and Technology have always been popular among the students.

Therefore, the University has also introduced AICTE approved B.Tech. Programme in Civil Engineering, Mechanical Engineering, Computer Science, Fashion Technology and Computer Science and Engineering with Artificial Intelligence and Machine Learning in the University since 2019. The University has also launched LL.M. programme and is striving to start LL.B. programme under the faculty of legal studies from the current session. The University is constantly making new endeavors to establish its identity as a Language University. Thus, apart from offering courses in Hindi, English, Sanskrit, Urdu, Arabic and Persian the University is also in the process of introducing specialized courses in other Indian and Foreign Languages to help the students learn a new language in addition to their regular academic programmes. University has also decided to offer courses pertaining to History and Culture of Language. In addition, Value Added Courses have been initiated by almost every department of the university to match the expectations of NEP 2020 guidelines.

This Memorandum of Understanding (hereinafter called as the 'MOU') is signed on 30 May, 2023 at New Delhi, India.

AND

The Khwaja Moinuddin Chishti Language University, Lucknow, hereafter, referred to as "**KMCLU**" which expression, unless repugnant to the text or context thereof shall include its successors and permitted assigns of the Second Part.

And have hereby decided that both parties would adhere to the following responsibility charter of listed below:

Section-1.0: MOU Signatories:

The signatories of the MOU will be GGSIPU and **KMCLU**.

Section-2.0: Objective:

To develop skilled manpower in the domains of interest such as management, psychology, communication, arts, Sociology, Hindi, Art, Film Studies, etc. through participatory mode.

Section-3.0: Engagement:

The scope of the Memorandum of Understanding is as under –

- (a) To design and deliver a training and certification programme in the domain for academicians and industry professionals at the national and international level;
- (b) To undertake collaborative research/consultancy in the relevant domains and new areas of areas of expertise with the involvement of teams from GGSIPU and KMCLU. The option of getting such research activities funded by the Govt. and other similar bodies may be explored.
- (c) To mutually plan and conduct lectures/ workshops/ symposia/ conferences/ other similar events in mutually agreeable areas at the national/international level.
- (d) That the promotion and publicity regarding the aforesaid programs/activities may be carried out jointly by GGSIPU and KMCLU through various online medium including but not limited to, Websites, Social Media, Newsletters, etc and offline mediums including but not limited to Newspapers, Billboards, Pamphlets, Brochures, Flyers, Posters, Banners, Flex, etc.
- (e) To undertake student and faculty exchange in areas of common interests.

Section-4.0: Duration of Engagement:

This MOU will be valid for a period of 3 years from the date of signing. Once the initial period of 5 years is over, the MOU will be extended for a further period of 3 years, with suitable changes (as per applicability) with mutual consent. If for any reason, any one entity of the MOU is desirous not to continue with the engagement. The same can be done by giving advance notice of one month.

Section-5.0: Dispute & Redressal:

That this MOU signed between the parties shall cease to exist after mutual agreement between both the parties at any point of time (within its validity period). However, both the parties have the responsibilities for completing the syllabus and arranging for examination/assessment & awarding certificate to already admit successful participants of any courses launched as per this MoU.

In case of any disputes of any kind between the GGSIPU and KMCLU, the decision of the Vice Chancellor of GGSIPU shall be final and binding on both the parties.
