WHEREAS, UGPF and KMCLU have a shared commitment to promoting education, research, and innovation that support the development of responsible, ethical, and compassionate members of society;

WHEREAS, UGPF operates online and offline language programs, organizes research, seminars, and online publications for graduate students to promote women's empowerment, rural development, social communication, environmental stewardship, and global peace and prosperity, and is constructing a quality library and school in a Bihar village to provide education and activities, particularly for girls and vulnerable children who are at risk of being lost due to inadequate educational institutions, supervision, and culture; and

WHEREAS, KMCLU is a state university that aims to achieve excellence in language, research, and innovation that supports the students in becoming productive, responsible, ethical, creative, and compassionate members of society;

The purpose of this MOU is to establish a framework for cooperation between UGPF and KMCLU to promote education, research, and innovation in language studies and related fields.

NOW, THEREFORE, the Parties hereby agree as follows:

ARTICLE 1: PURPOSE

The purpose of this MOU is to establish a framework for cooperation between UGPF and KMCLU to promote education, research, and innovation in language studies and related fields.

ARTICLE 2: SCOPE OF COOPERATION

UGPF and KMCLU agree to cooperate in the following areas:

- 1. To explore the possibilities of joint research activities, conferences, workshops, and other academic activities of mutual interest;
- 2. To provide students of KMCLU access to UGPF's language programs, research, and other resources;
- 3. To provide students of UGPF access to KMCLU's language programs, research, and other resources;
- 4. To collaborate on the development of new language programs and curriculum;
- 5. To explore the possibilities of student and faculty exchange programs;
- 6. To collaborate on the development of research projects related to language studies and related fields; and
- 7. To promote cooperation and exchanges between the faculties and researchers of UGPF and KMCLU.

ARTICLE 3: FINANCIAL ARRANGEMENTS

- 1. Each Party shall bear its own cost and expenses in the implementation of this MOU.
- In any of the activities mentioned above, wherever financial aspects are involved, amount, payment conditions, etc. would be spelt out clearly before starting the activity.

ARTICLE 4: EFFECTIVE DATE AND DURATION OF MOU

This MOU shall become effective on the date of signatures of both parties and will be valid for a period of five years from the date of signature and may be extended further with the written consent of both parties.

ARTICLE 5: INTELLECTUAL PROPERTY RIGHTS

Both Parties undertake that they shall not infringe upon any copyright or in exclusive possession of the respective Parties. Both parties shall obtain permission in writing for the usage of any logo, motif, emblem, or any other intellectual property right vested in the respective Parties to be used in connection with the implementation of the present MOU from the respective Party. Each Party is the sole owner of such intellectual property.

ARTICLE 6: CONFIDENTIALITY

Both Parties agree to maintain confidentiality and not to disclose any information to any third party, unless permitted in writing by the other Party or required by law. The Parties shall take appropriate measures to safeguard the confidential information and ensure that it is not used for any purpose other than for the implementation of this MoU.

ARTICLE 7: DISPUTE RESOLUTION

Any dispute or difference arising out of or in connection with this MoU shall be resolved amicably between the Parties through mutual consultation, negotiation and agreement. If the Parties are unable to resolve any dispute, they may refer it to mediation, and if it remains unresolved, it may be referred to a mutually agreed-upon arbitrator for resolution. The decision of the arbitrator shall be binding on both Parties. The arbitration shall take place in a mutually agreed-upon location and shall be conducted in accordance with the rules of the Indian Arbitration and Conciliation Act, 1996, or any subsequent amendments thereof.

ARTICLE 8: TERMINATION

Either Party may terminate this MoU at any time with written notice to the other Party, giving at least one month's notice. Upon termination, the Parties shall promptly settle all outstanding obligations under this MoU.

ARTICLE 9: MODIFICATION

Any modification or amendment to this MoU shall be made in writing and shall be signed by both Parties. The modification or amendment shall become effective upon the date of signature of both Parties.

ARTICLE 10: NOTICES

All notices and other communications required or permitted to be given by either Party under this MOU shall be in writing and shall be deemed given when (i) delivered in person, (ii) sent by registered or certified mail, postage prepaid, return receipt requested, or (iii) sent by email, provided that the sender receives confirmation of receipt. Notices shall be addressed to the Parties at the addresses or to such other addresses as either Party may specify in writing.

ARTICLE 11: GOVERNING LAW

This MOU shall be governed by and construed in accordance with the laws of India. Any disputes arising from or in connection with this MOU shall be resolved amicably between the Parties through mutual consultation, negotiation, and agreement. If such disputes cannot be resolved amicably, the disputes shall be submitted to arbitration in accordance with the Arbitration and Conciliation Act, 1996, or any statutory modification or reenactment thereof, and the award of the arbitration shall be binding and final upon the Parties.

ARTICLE 12: ENTIRE AGREEMENT

This MOU constitutes the entire agreement between the Parties and supersedes all prior negotiations, representations, and understandings between the Parties relating to the subject matter hereof. No amendment, supplement, or modification of this MOU shall be binding unless it is in writing and signed by authorized representatives of both Parties.
