1. About the University

Language plays a pivotal role in shaping the identity of a nation. It serves as a medium for identification, creation, preservation and dissemination of knowledge, enabling individuals and communities to engage with the global community. The study of language captivates numerous scholars and thinkers, inviting exploration of its multifaceted dimensions. Government initiatives are underway to connect language with the nation's heritage and encourage high-quality research in this domain. The National Education Policy (NEP 2020) highlights the importance of fostering multilingualism and utilizing language's power in educational practices. Aligned with these efforts, the University is actively contributing to the advancement and promotion of languages.

Established under the Uttar Pradesh Arabi Farsi Universities Act 2009 (U.P. Act No. 12 of 2009), this institution was named 'Khwaja Moinuddin Chishti Urdu, Arabi-Farsi University' through an Amendment in 2012, honouring the revered Sufi Saint Khwaja Moinuddin Chishti of Ajmer, whose ethos of simplicity and generosity has left a profound impact worldwide. The University holds the esteemed status of 12B and 2f by the University Grants Commission.

In February 2020, the State Government Cabinet approved the proposal to rename the institution as 'Khwaja Moinuddin Chishti Language University.'

Situated at Sitapur-Hardoi Bypass Road, the University is dedicated to imparting quality education while instilling in its students a profound understanding of the nation's cultural tapestry, encouraging them to actively contribute to the evolution of a knowledge-driven society.

The University commenced its inaugural academic session in August 2013, offering a diverse array of disciplines including Urdu, Arabic, Persian, English, Hindi, Geography, History, Economics, Home-Science, Physical Education, Political Science, Education, Commerce, Computer Science, Business Administration and Journalism and Mass Communication at both the Graduate and Postgraduate levels. Additionally, Diploma Programmes have gained popularity among students attending the University. Presently, the student body has grown to 4,115 reflecting a significant increase in the number of programmes offered.

Since its inception, the University has experienced substantial growth in scale and academic offerings. It now provides a wide spectrum of educational opportunities to students from across the state and beyond. With a harmonious blend of professionalism and tradition, the University has carved a distinct niche in the academic landscape of Uttar Pradesh.

The University has introduced AICTE-approved B.Tech. Programmes in Civil Engineering, Mechanical Engineering, Computer Science, Computer Science and Engineering with Artificial Intelligence and Machine Learning in 2019. The University has also initiated Ph.D. programme in all disciplines. Additionally, the University successfully running LL.M. and LL.B. programmes under the faculty of legal studies. Moreover, Diploma and Bachelor of Pharmacy programmes commenced from the academic session 2023-24.

In its pursuit to establish itself as a Language University, the institution offers programmes in Hindi, English, French, Sanskrit, Urdu, Arabic, Persian, German, Chinese, Japanese and Pali. The University is in the process of introducing specialized programmes in other Indian and



Foreign Languages, along with courses on the History and Culture of Language. Value-added courses have been introduced across departments to align with the guidelines outlined in NEP-2020.

Recognizing the importance of sports and physical activities along with academic pursuits, the University integrates Physical Education into its undergraduate curriculum and hosts regular sports events on campus. In addition to physical security measures, the University has implemented digital security protocols by installing CCTV cameras throughout the premises. Moreover, free Wi-Fi access is provided to all the students, faculty members and non-teaching staff, enhancing connectivity and accessibility across the campus.

2. Infrastructure & Services

The University has several infrastructural amenities to cater to the academic needs of the students.

Abul Kalam Azad Academic Building

The Academic Building of the University features air-conditioned classrooms equipped with projectors to facilitate audio-visual teaching and learning. It has an auditorium, faculty rooms for instructors and seminar/conference halls for engaging in debates, discussions and other academic endeavors. To ensure convenience for both students and teachers, each floor of the academic building features a dedicated reading room, fostering a conducive environment for learning and scholarly activities.

Labs

The Academic Building hosts a Geography Lab for students and a separate SPSS lab for research scholars, providing training in software operation and data analysis for their research endeavours.

The Department of Computer Science maintains an internet-supported Computer Lab accessible to faculty members and students for research and academic purposes. Additionally, all other departments are equipped with computer labs to enhance students' proficiency in utilizing ICT within their respective fields. The labs and workshops of Chemistry, Physics, Electrical, Electronics, Biotechnology, Civil and Mechanical as well as Media Lab also working properly.

In alignment with global standards for language proficiency, the University has established state-of-the-art language labs. Departments of Arabic, Persian, English and Urdu are equipped with their own language labs where students are trained to hone up their skills of language proficiency.

Acharya Narendra Dev Administrative Building

The striking Administrative Building stands as a prominent landmark welcoming students and visitors upon entering the University campus. Throughout the day, this block is bustling with activity, managing a wide array of student affairs and financial matters. Additionally, the offices of the Vice Chancellor, Finance Officer, Controller of Examinations and Registrar are housed within this building.



Video Conferencing Hall

One of the major attractions of this building is the multipurpose conference room equipped with latest tools of communication including facilities of video conferencing.

Students' Facility Centre (SFC)

The Student Facility Center (SFC) commenced operations in the academic year 2021-22. It offers various student amenities, including a canteen, print and photocopy shop and stationary shop. A common room for girls, along with a hobby room furnished with indoor games, has been established to offer recreational opportunities for female students. Furthermore, the building accommodates offices for the National Cadet Corps (NCC) and National Service Scheme (NSS), which spearhead various social welfare initiatives within and beyond the University campus.

Study Centre

The Study Centre represents the University's latest addition to its impressive infrastructure. Designed to foster learning and research endeavors, the Centre accommodates the Deen Dayal Upadhyay Shodhpeeth, Department of Home Science, Department of Journalism and Mass Communication and the Centre for English & Modern European and Asian Languages.

Pandit Deen Dayal Upadhyaya Shodhpeeth

The University also holds the distinction of being a pioneer in establishing Pt. Deen Dayal Upadhyay Shodhpeeth. Uttar Pradesh State Government established the Shodhpeeth in the year 2017 at this University. The aim of this Shodhpeeth is to assimilate knowledge related to life, thought and philosophy of Pt. Deen Dayal Upadhyay and promote dialogue and research in the area. Besides other regular research and academic activities, various seminars are organized by the Shodhpeeth from time to time, to familiarize the students with the thoughts and vision of the great leader.

Community Health Centre

The University has entered a Memorandum of Understanding (MoU) with the Career Institute of Medical/Dental Sciences, IIM Road, Lucknow and Balrampur Hospital, Kaiserbagh, Lucknow. Through these MoUs, all University students, faculty and staff can access OPD, dental and hospital services at both the hospitals for a nominal fee. The hospital extends also ambulance services to the University in case of emergencies.

The University's Community Health Center addresses the medical requirements of both students and staff. It operates a 24-hour Outpatient Department (OPD) facility and is well-equipped to handle emergency situations. A nurse is available at the Center round the clock, while a doctor is accessible for consultation four hours each day.



E-Learning

The spread of digital technologies has brought about the realization of a global village. In the pandemic era, terms like e-learning, virtual classrooms, web-based learning, LMS and virtual labs have transitioned into reality. Therefore, in order to ensure uninterrupted learning experiences for students, the University offers the flexibility to conduct both online and offline classes.

A comprehensive e-content repository has been created by the faculty members and is accessible across various online platforms for student convenience. Moreover, to enhance audio-visual learning, the University maintains an official YouTube Channel featuring over 500 video lectures prepared by faculty members covering a diverse range of subjects.

Indoor Theatre

Within the Student Facility Centre (SFC), students with an interest in performing arts and theatre can utilize the Indoor Theatre, where regular cultural events are hosted.

Ashfaq Ullah Khan University Guest House

In addition to academic pursuits, extra-curricular activities are a common occurrence at the University, attracting participants from both domestic and national level. As hosts, the University ensures their comfortable accommodation at the Guest House, which is furnished with modern amenities.

Media Studio

The University has inaugurated a cutting-edge Media Studio within the Department of Journalism and Mass Communication to offer hands-on training to its students. The studio is outfitted with advanced equipment including high-definition indoor and outdoor cameras, a teleprompter, interactive screens and a state-of-the-art editing system. It is fully equipped to facilitate the recording of video lectures and the production of top-tier films. The studio features a dedicated audio section for voiceovers, recordings and radio training. Various workshops focusing on shooting, audio recording and editing are regularly conducted for students within the studio premises.

Transportation Facility

Various modes of transportation are accessible to students for traveling between the University and the city.

Ram Prasad Bismil Library

The University Library offers a conducive study environment for students, faculty and visitors, presenting a wealth of knowledge through its extensive collection of books and online resources. Its diverse collection covers a wide array of subjects, while also subscribing to numerous periodicals, magazines and journals to keep students informed about contemporary developments in their respective fields of study.



University Gymnasium

Recognizing that good health is essential for success, the University prioritizes the overall well-being of its staff and students. To this end, it has established a Gymnasium, offering a comprehensive range of health and recreational facilities under one roof. The gymnasium boasts state-of-the-art exercise equipment and indoor amenities such as table tennis and badminton courts, fostering health awareness throughout the campus. The Gymnasium is dedicated to provide rigorous training to the University athletes and sports enthusiasts.

Basketball Court and Net- Practice Facility

The University also features a basketball court and a cricket net practice pitch to train students in outdoor activities and prepare them for both intra-college and inter-college competitions.

Hostel Facility

The University has separate boys' and girls' hostels that provide convenient accommodation for the students with in house mess facility. The boys' hostel has a capacity of around 300 students and the girls' hostel also offers an accommodation for 300 students. To make the stay of the students pleasant and enjoyable, various activities, events and celebrations are organized within the hostels on a regular basis. Both the hostels are enabled with free wi-fi services and indoor games. CCTV cameras have also been installed to maintain safety and security. The allotment of rooms is made as per the rules, guidelines and relevant regulations of the University.

The Hostel facility is available at quite an affordable cost. The facility of single occupancy is available only for Ph.D. students. Besides this, students will have to pay the mess charges for availing the mess facility, that is compulsory for every resident. (For further details kindly visit the University website.)

Awadh Incubation Foundation (AIF)

The Awadh Incubation Foundation (AIF) is incorporated as a Not-For-Profit Section 8 Company, guided by a competent and qualified Board of Directors. Situated at Khwaja Moinuddin Chishti Language University, Lucknow, a state-funded institution, AIF benefits from access to the University's Wi-Fi-enabled infrastructure. This includes classrooms equipped with LCD projectors, technical laboratories, seminar halls, conference rooms, boardrooms, computer labs, libraries, cafeterias, vehicle parking and other essential facilities.

AIF welcomes all students and alumni of the University, as well as individuals with business ideas ready for launch. We also extend support to aspiring start-ups and entrepreneurs in need of incubation assistance to elevate their ideas to the next level. The vision at AIF revolves around leveraging education and technology inputs, particularly those available or developed at our University, to benefit industries, agriculture, healthcare and various domains of expertise in the new century. We aim to contribute to the enhancement of the socio-economic structure of the country.

AIF offers access to office space, business advisory services and other forms of support to emerging start-ups, nurturing their growth until they are prepared to transition into full-fledged businesses.



Centre of Excellence

- **Centre of Excellence under the Department of Arabic**

Centre of Advanced Studies has been established under the Department of Arabic with the grant from Dept. of Higher Education, U.P. with the aim to enhance modern communication skills with traditional colloquialisms for Arabic and other languages. The purpose of this Centre is to work on the use of new technologies in the field of Arabic education in collaboration with other Indian and Foreign Universities.

- **Centre of Excellence under the Department of Commerce (CED)**

The Centre for Entrepreneurship Development (CED) operates as a hub of excellence within the Department of Commerce. Established with funding from the Government of Uttar Pradesh, its primary objective is to recognize entrepreneurial aptitude among students and offer mentorship and assistance to budding entrepreneurs. 2. GENERAL GUIDELINES FOR ADMISSION 2024-25

2.1 Candidates are required to read the Prospectus carefully before filling in the Application Form for admission to the programmes of study offered at Khwaja Moinuddin Chishti Language University. The Prospectus provides general information and is subject to the provisions of the Act, Statutes, Ordinances, Regulations and relevant Resolutions of the University.

2.2 The University reserves the right to make any change/modification in the provisions made in this Prospectus and the same shall be duly notified on the University website. The candidates shall not be informed of any such change individually.

2.3 The candidates, who have appeared at the qualifying examination but whose results have not been declared, may also apply for admission. They must, however, submit their results/mark-sheets by the last date of admission as per the list in which their names appear. Any subsequent production of result/certificate of the qualifying examination shall not be considered.

2.4 No candidate shall be entitled to claim admission as a matter of right.

2.5 Request for relaxation in gap years after qualifying examinations may be considered by the Admission Committee.

2.6 Admission of a candidate may be cancelled at any time, if any information furnished by the candidate at the time of admission is found to be incorrect or if the candidate has been wrongly admitted due to any reason. A legal action will also be initiated against the student found guilty of submitting forged or incorrect documents under IPC.

2.7 Ragging in the University is an offence prohibited as per the directives issued by the Hon'ble Supreme Court of India. Strict action will be taken against the students found guilty of ragging and/or abetting ragging. The candidates admitted to various programmes in the University shall be liable to submit an undertaking assuring not to indulge in any form of ragging. Action will be taken against the students who are involved in any kind of ragging as per the rules.

4. IMPORTANT GUIDELINES FOR FILLING THE APPLICATION FORM

4.1 The candidates willing to apply for more than one Programme will have to submit separate form for each Programme of study. Application Forms shall not be transferred from one Programme of study to another.

4.2 Students must submit self-attested photocopies of the required documents along with the Application Form. The original Migration/Transfer Certificate should be submitted at the time of counseling.

4.3 It is the sole responsibility of the candidate to ensure his/her eligibility before applying for admission to a particular programme. No claim of any sort in this matter shall be entertained by the University after the submission of the Form.

4.4 Payment of fee by cheque shall not be accepted.

4.5 The Application Fee is non-refundable and no correspondence in this respect will be entertained.



4.6 The applicants to all Programmes offered by the University under 'Reservation of Seats' or applicants claiming benefit under 'Special Provision for Admission' must attach self-attested photocopies of the certificate of the Reserved/Special category issued by a competent authority, along with their Application Forms/ Registration at the time of counseling.

5. ADMISSION PROCEDURE

5.1 Admission to all Undergraduate and Postgraduate Programmes offered by the University will be based on merit drawn based on the qualifying examination.

5.2 The Merit for students applying to Undergraduate and Postgraduate Programmes will be determined as under:

- For Session 2024-25, the Undergraduate and Postgraduate students shall be admitted based on the total marks secured in the qualifying examinations.
- If two or more candidates secure equivalent marks/rank in the merit list, the elder one among the candidates will be given a preference.

6. ADMISSION OF FOREIGN/ NRI STUDENTS

6.1 Foreign/NRI students can take admission in any subject of their choice being offered by the University.

6.2 The University Prospectus, stating all admission guidelines and eligibility criteria can be accessed on the University website www.kmclu.ac.in

6.3 Eligibility qualifications for foreign students will be the same as for Indian students for each programme mentioned in the University Prospectus.

6.4 Only those students who have qualified from Foreign Universities or Boards of Higher Education, recognized equivalent by the Association of Indian Universities (AIU) are eligible for admission.

6.5 On being granted admission, all applicants (except those applying for research visa) should produce their Student Visa within one month of completion of admission formalities.

Note: The admission fee of Foreign/NRI Students will be displayed on the University website before the last date of submission of Application Form.



7. COMPLETION OF ADMISSION FORMALITIES

7.1 The selected applicants must complete their admission formalities as per the Admission Schedule.

7.2 At the time of admission, the applicants shall be required to produce the following documents in original with one set of self-attested photocopies of the same, failing which their admission is liable to be cancelled.

5	EWS (Economically Weaker Section) Certificate, Caste Certificate (SC/ST/OBC) issued by the competent authority based on which the reserved seat is being claimed.
6	Any other Certificate based on which the reservation and weightage is being claimed.
7	Prescribed Fee

Note: Admission shall be subject to the verification of these documents.

7.3 For admission to the Diploma programme, the working candidate is required to submit a 'No Objection Certificate' from their present employer. Self-employed candidates shall provide authentic evidence in support of their self-employment.

8. RULES FOR ADMISSION

8.1 Admission to all Programmes shall be subject to the provision of the Act, Statutes, Ordinances, Regulations and the relevant Resolutions of the University.

8.2 As per the guidelines of the Executive Council, all Undergraduate, Postgraduate and Diploma Programmes of the University will be run with a minimum enrollment of 10 students under each Programme.

8.3 If a candidate fails to complete the admission formalities by the prescribed date, his/her claim for admission will be automatically forfeited.

8.4 The admission of a candidate will not be completed unless he/she deposits the fee within the stipulated time as fixed by the University.

8.5 No candidate will be allowed to take up a job while pursuing a full-time programme. Those who are employed at the time of admission will be required to produce a certificate of leave from their employer within one month from the date of admission, failing which their admission may be cancelled.

8.6 No candidate, pursuing a regular full-time programme in University will be allowed to take up any other regular examination except for Diploma Programmes.

8.7 All disputes regarding the admission shall be referred to the Admission Committee/Vice Chancellor of the University and their decision shall be final and binding.

8.8 All legal matters pertaining to the admission shall be subject to Lucknow Jurisdiction only.

8.9 University reserves the right to cancel any admission at any stage.

OR Candidates who are appearing for their final semester exam are also eligible to apply for UPSEE Lateral entry 2024 but, only if they meet the eligibility criteria by the time of counselling.</i>

14 Reservation of Seats

8.10 Seats under various programmes of the University shall be reserved for certain categories of candidates belonging to reserved groups like Scheduled Caste, Scheduled Tribe, Other Backward Classes and Economically Weaker Section (EWS). The procedure adopted for the purpose of admission will be as per the norms and guidelines decided by the University/State Government from time to time.

8.11 Candidates seeking admission under the reserved categories shall be required to fulfill the prescribed admission requirement of the programme.

8.12 If a candidate in the reserved category qualifies for admission in the General Category, he/she shall be treated as general candidate.

(b) Each Category/Sub-Category must be supported by the relevant certificates as per proforma prescribed by state government or Competent Authority, to be produced at the time of counseling, failing which the candidates shall be treated under General Category.

15 Special Provisions for Admission

A candidate fulfilling the requirements of Special Category seat shall be entitled to a weightage in marks (if any) as per the criteria mentioned below:

15.1 Outstanding Sportsperson

Seats under various Programmes of the University shall be reserved or special provisions be made for Outstanding Sportspersons. The weightage will be given to the players who have represented Uttar Pradesh in National, Inter-state or Inter-regional competitions in last two years and the competitions have been organized by State Sports Organizations recognized by the Competent Authorities. The procedure adopted for the purpose of admission may be as per the details given below or as may be decided by the Academic Council/U.P. Government from time to time.

- Weightage to the extent of 5% of marks in aggregate or in the subject concerned, as the case may be, will be given to such candidates.
- An additional seat may be created for such students over and above the seats allotted to each Programme on the recommendation of the Games and Sports Committee subject to the approval of the Vice-Chancellor.
- All the Sportspersons selected for admission under sports quota shall have to give an affidavit of consent for conducting/participating in practice/representing the University team on being selected to do so, before they are admitted.
- To claim the sports weightage, the candidate will have to present himself before the Sports Committee for a trial.
- Department of Physical Education may be contacted for any admission related queries under this Category.



15.2 N.C.C.

Weightage to the extent of 2.5% marks in aggregate or in the subject concerned, as the case may be, will be given to cadets having the following N.C.C. Certificates for admission to all programmes.

- "A" or "B" Certificate for admission to Undergraduate programmes.
- "C" Certificate for admission to Postgraduate programmes.

15.3 N.S.S.

N.S.S. Volunteers, who have attended a minimum of two, 7 days and 10 Days Special Camps may be provided a weightage of 2% marks in aggregate or in the subject concerned as the case may be, for admission to all programmes.

15.4 Kashmiri Migrants

In compliance to the directions of Department of Higher Education, Ministry of Education, the University has special provisions for Kashmiri Migrants. However, they must apply and go through the entire admission process to be eligible for the following reservation/relaxation.

- They may be permitted a relaxation in cut off percentage to the extent of 10% of marks subject to the fulfillment of minimum eligibility requirement of the programme applied for.
- Their admission will be considered over and above, not exceeding 5% of the total seats in the programme applied for.
- Candidates seeking admission under this category will not be required to submit domicile certificate. However, they will have to submit a certificate in support of their claim of being Kashmiri migrants obtainable from the concerned authorities.

16 Attendance

Subject to the Uttar Pradesh State Universities Act-1973 (As Amended) Sub section 2(c) of Section 51 and the First Statutes of the University, attendance for the regular students shall be governed as per the following provisions:

16.4 In order to be eligible to appear at the Semester End Examination, a student shall be deemed to have undergone a regular Programme of study in the University if he/she has attended at least 75% lectures/tutorials and separately 75% practical/field work teaching practice and such other activities as decided by the Academic Council from time to time.

16.5 Provided further that a relaxation to the maximum extent of 15% of the total attendance may be accorded to a student on account of serious sickness/excruciating medical disability, participation in the University-approved co-curricular/extra-curricular activities and prescribed educational/cultural tours.

16.6 Provided further that in case of medical disability as mentioned herein above, an application for condonation shall be supported by a medical certificate advising such a condonation issued by a Public Hospital or such hospitals as notified by the University. Such applications must be submitted either during the period of treatment/hospitalization or within 15 days following recovery.



17 General Rules Regarding Admission/ Cancellation / Fee Refund

17.1 The fee mentioned in the Prospectus is only for the current academic year and may be changed in the next academic year.

17.2 If a student requests through proper channel to cancel his/her admission for any valid reason, the fee will be refunded as per the University norms. All charges except admission and enrollment fee will be refunded only if the admission is cancelled within one month or till the last date of admission, whichever is earlier. In other cases, no fee except caution money will be refunded in any circumstances and no correspondence in this regard will be entertained.

17.3 If a student does not claim the refund of his/her credit balance within one year of leaving the University, the amount standing to his/her credit shall be forfeited.

17.4 The Caution Money of a regular student will be refunded only after the declaration of the final examination results. If it remains unclaimed for more than one year from the date of announcement of the result, it shall not be refunded.

17.5 Students admitted to the Diploma Programmes in addition to full-time programme of the University shall be charged the following fees:

- Tuition Fee
- Admission Fee
- Examination Fee
- Development Fee



18 Bodies/ Committees of the University

18.1 INTERNAL QUALITY ASSURANCE CELL (IQAC)

The best path towards success is regular self-monitoring and upgradation. Thus, in pursuance of the recommendations of National Assessment and Accreditation Council (NAAC), the University has established an Internal Quality Assurance Cell (IQAC). The Cell regularly accesses the academic facilities and suggests measures to upgrade the quality of overall performance of the University. The Cell comprises of different committees to assess, monitor and advise on the best practices to improve and enhance the overall functioning of the University. It is committed towards enabling this University to achieve academic excellence.

18.2 PROCTORIAL BOARD

The Proctorial Board of the University headed by Proctor and supported by Assistant Proctors, ensures that the students of the University abide by the rules and regulations framed by the University. It works towards maintaining a harmonious atmosphere in the campus and ensures smooth functioning of the campus activities. The board also resolves student's grievances and works progressively towards safeguarding their interest.

18.3 INTERNAL COMPLAINTS COMMITTEE

Gender equality, including protection from sexual harassment at workplace and right to work with dignity is a universally recognized human right. In compliance with the instructions of National Commission for Women and guidelines issued in implementation of the directives of Hon'ble Supreme Court Judgement dated 13th August, 1997 in the case of Visakha and others vs. State of Rajasthan and Others on the subject of sexual harassment of women at workplace, this University had duly constituted a Complaint Committee for considering complaints of sexual harassment of women working at University. This cell is dedicated towards creating a congenial environment in the campus where every woman feels safe and confident. The members of the cell also conduct regular meetings and organize activities to create awareness towards prevention of harassment and violence against women and gender sensitization.

18.4 ANTI – RAGGING COMMITTEE

Anti-Ragging Committee of the University is an advisory and supervisory body that works towards providing a ragging free environment in the campus. Its primary aim is to keep a vigil and put a tab on the incidents of ragging. The members of the committee conduct regular inspections of classrooms, canteen and other places of student assembly for any incidence of Ragging. The committee also holds orientation sessions with the students to educate them on the menace of ragging and related punishment provisions. The proctor functions as the coordinator of this committee.

18.5 GENDER SENSITIZATION COMMITTEE

As gender sensitization is a process of behavioral change by instilling empathy into the views that people hold about their own and other sex. The constitution of India provides for equality of status and opportunity to all the citizens. it is imperative for the students to be aware



of the issues related to gender. The University has constituted a committee to sensitize all stakeholders with regards to equality in law, social systems and democratic activities.

18.6 NATIONAL CADET CORPS (NCC)

The National Cadet Corps (NCC) is the youth wing of the Indian Armed Forces with its headquarters in New Delhi, India. It is open to school and college students on voluntary basis as a Tri-Services Organization, comprising the Army, the Navy and the Air Wing, engaged in developing the youth of the country into disciplined and patriotic citizens. The soldier youth foundation in India is a voluntary organization which recruits cadets from high schools, higher secondary, colleges and universities all over India. The Cadets are given basic military training in small arms and drills. The University has a unit of girls' battalion comprising on 80 female students.

18.7 NATIONAL SERVICE SCHEME (NSS)

The National Service Scheme has been initiated in the University with the aim to develop overall personality of the students through community service. The students enrolled under the scheme take part in a variety of developmental activities like tree plantation, creating awareness among students on relevant social issues, conducting cleanliness drives and several other activities aiming towards the betterment of the community. The ultimate goal of the scheme is to inculcate and strengthen the feelings of patriotism, national integration, brotherhood and communal harmony among the volunteers and through them, in the society. Presently, the University has five separate NSS units.

18.8 ROVERS-RANGERS

In the previous academic year, KMCLU added another feather to its cap as it proudly established its first Rovers and Rangers unit in the University. With the aim of holistic development and spiritual growth, KMCLU is relentlessly striving to hone the skills and talents of students in producing the leaders of the future. An orientation programme was organized to familiarize students with its numerous activities and opportunities.

18.9 SCHOLARSHIP COMMITTEE

The University has a scholarship committee that helps the students in availing benefits of U.P State Government scholarships. This scholarship is accessible to the students belonging to all categories namely SC, ST, OBC, Minority and General hailing from economically weaker sections of the society. It aims to instill confidence among these students, motivate them for higher education and bring them in the mainstream of education system.

The Committee also aids the Minority students in availing the benefits of Minority Welfare Scholarship System/Scheme. Under this scheme, scholarships are provided to the meritorious students of these communities. It is aimed towards preserving their right to education, providing them with greater opportunities in higher education and enhancing their chances of employability.

The Committee also provides guidelines to the students regarding other scholarship schemes of the government.



18.10 CULTURAL COMMITTEE

The Cultural Committee works for interpersonal learning of various arts and creative skills by conducting various events and activities. The Cultural Committee shall be responsible for all intra and inter collegiate cultural events in the University. The Committee makes plans and schedules of all the cultural events for the academic year. Events like COSAC and foundation day are celebrated every year in October. Various other occasions as Abul Kalam Azad Jayanti, Atal Bihari Bajpayee Jayanti, Sardar Vallabh Bhai Jayanti, Valmiki Jayanti, Gandhi Jayanti, National festivals are celebrated with great zeal and enthusiasm.

18.11 TRAINING AND PLACEMENT CELL

In the present contemporary and competitive environment, education is not only a mode of transmitting knowledge but also a tool that equips the students with requisite professional skills that prepare them for the upcoming job opportunities.

The Placement Cell of the University helps the students to identify organizations suited for training and future placement. It is dedicated to support the students in their pursuit to get jobs in various reputed organizations. In addition to this, the placement cell also conducts special lectures and workshops to update the students on current job opportunities and trends in their chosen area of study.
